**RESOLUTION NO. 398-2020**

**APPROVING SB RESOLUTION NO. 165-2020 OF THE SANGGUNIANG BAYAN OF MANGATAREM, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 2 FOR CY 2020 OF MANGATAREM, PANGASINAN”**

**WHEREAS**, the Sangguniang Bayan of Mangatarem, Pangasinan submitted its SB Resolution No. 165-2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109, 114 of RA 7160. The Local Development Council of Mangatarem, Pangasinan had identified items in their Supplemental Investment Program No. 2 for CY 2020. This was endorsed to the Sangguniang Bayan for approval on April 13, 2020 by the MDC thru Executive Committee Resolution No. 03, S-2020 and was favorably acted upon by the Sangguniang Bayan on April 15, 2020 thru SB Resolution No. 165-2020;

**WHEREAS**, the Supplemental Investment Program No. 2 of the municipality covers the programs, projects and activities in response to the crisis brought about by the COVID-19 pandemic, which are based on Local Budget Circular No. 125 of the Department of Budget and Management dated April 7, 2020 – “Guidelines on the Release and Utilization of the Bayanihan Grant to Cities and Municipalities”;

**WHEREAS**, the proposed Supplemental Investment Program has an investment requirement of P19,215,880.00. Funding support for the implementation of the same is embodied in their proposed Supplemental Budget No. 2 CY 2020, which was passed and approved by their Sangguniang Bayan on April 15, 2020 thru Appropriation Ordinance No. 02, Series of 2020;
