#### **RESOLUTION NO. 398-2021**

APPROVING SB RESOLUTION NO. 89-2021 OF THE SANGGUNIANG BAYAN OF MANGATAREM, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 1 FOR CY 2021 OF THE MUNICIPALITY OF MANGATAREM, PANGASINAN"

**WHEREAS**, the Sangguniang Bayan of Mangatarem, Pangasinan submitted its SB Resolution No. 89-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109, 114 of RA 7160. The Local Development Council of Mangatarem, Pangasinan had identified items in their Supplemental Investment Program No. 1 for CY 2021. This was endorsed to the Sangguniang Bayan for approval on March 15, 2021 by the Municipal Development Council through Executive Committee Resolution No. 01, S-2021;

**WHEREAS**, the Supplemental Investment Program No. 1 of the municipality covers fund augmentation for the Personal Services, Maintenance and Other Operating Expenses of various municipal offices and implementation of disaster risk reduction programs and other development projects of the municipality;

**WHEREAS**, the proposed Supplemental Investment Program has an investment requirement of P19,639,478.00. Funding support for the implementation of the same is embodied in their proposed Supplemental Budget No. 1, CY 2021, which was passes and approved by their Sangguniang Bayan on March 24, 2021 through Appropriation Ordinance No. 01, S-2021;
