RESOLUTION NO. 399-2022

APPROVING RESOLUTION NO. 2022-031 OF THE SANGGUNIANG BAYAN OF SISON, PANGASINAN, ENTITLED "APPROVING THE 1ST SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM-CY 2022 OF THE MUNICIPALITY OF SISON, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Sison, Pangasinan submitted its Resolution No. 2022-031 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council of Sison, Pangasinan had identified items in their 1st Annual Supplemental Investment Program (SAIP) for CY 2022, which was endorsed to the Sangguniang Bayan for approval on February 4, 2022 through MDC Resolution No. 01-2022, Series of 2022;
2. The 1st SAIP of the municipality covers the implementation of various programs/projects/activities under maintenance and other operating expenses and capital outlay of the LGU with a total investment requirement of Php50,214,319.45 and is supported by Supplemental Budget No. 01 which was enacted by the Sangguniang Bayan on February 14, 2022 through Appropriation Ordinance No. 01, Series of 2022; and

3. Also included in the SAIP are programs/projects to be funded under the 2021 MDRRM Trust Fund amounting to Php 5,115,388.52.

WHEREAS, however, the programs/projects to be funded by the 2021 MDRRM Trust Fund (Item No. 3 of subject Supplemental AIP) is not approved. The LGU is advised to observe Item 6.5 of the NDRRMC-DBM-DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2015 which states: *The unexpended balances of the LDRRMF may be released and utilized for new expenditure items upon submission of a revised AIP ass approved by the local sanggunian and Local Chief Executive (LCE), upon recommendation of the LDRRMC in accordance with the approved LDRRMF;*




