**REQUESTING THE HONORABLE FRANCISCO T. DUQUE III,
SECRETARY OF THE DEPARTMENT OF HEALTH, TO CAUSE
THE ALLOCATION OF FUNDS FOR THE ESTABLISHMENT OF A
PROVINCIAL OXYGEN PLANT IN PANGASINAN**

WHEREAS, one of the primordial health concerns of the Province of Pangasinan is to save the life of every Pangasinense;

WHEREAS, oxygen is a basic requirement in order to save the lives of ill patients or persons undergoing emergency situations;

WHEREAS, the Provincial Government of Pangasinan, through its fourteen (14) provincial government hospitals, is in need of support from higher authorities, particularly the Department of Health, in order to realize a worthwhile project that can provide a convenient, sustainable and cost effective service of oxygen to health facilities;

WHEREAS, establishment of a provincial oxygen plant in Pangasinan is a suitable and favorable option in administering a point-of-care oxygen in the Province;

WHEREAS, it is important to ensure that a life-saving oxygen plant is necessary to be established in the Province and be included in the health planning budgets;

WHEREAS, the Sangguniang Panlalawigan strongly believes that having a reliable source of oxygen in the Province is necessary to protect the health and welfare of the people of Pangasinan;


