APPROVING RESOLUTION NO. 125, S-2018 OF THE SANGGUNIANG BAYAN OF ROSALES, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL INVESTMENT PLAN NO. 01, CALENDAR YEAR 2018 OF THE MUNICIPALITY OF ROSALES, PANGASINAN"

**WHEREAS**, the Sangguniang Bayan of Rosales, Pangasinan submitted its Resolution No. 125, Series of 2018 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of Rosales, Pangasinan has formulated the municipality's Supplemental Investment Plan No. 1 and endorsed to the Sangguniang Bayan for approval thru MDC Executive Committee Resolution No. 0815, S-2018 dated August 15, 2018. This was subsequently approved by their Sangguniang Bayan thru Resolution No. 125-2018 dated August 30, 2018. This is in consonance to Sections 106, 109 and 114 of RA 7160;

WHEREAS, the Supplemental Investment Plan of the municipality with an investment requirement amounting to P6,613,941.26 covers the fund augmentation for personal services, maintenance and other operating expenses, capital outlay of offices and disaster risk reduction management activities of the municipal government;
