APPROVING RESOLUTION NO. 55, S-2019 OF THE SANGGUNIANG BAYAN OF UMINGAN, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL INVESTMENT PLAN AND OTHER RELATED ACTIVITIES RELATED TO APPROPRIATION OF THE UNAPPROPRIATED SURPLUS FROM THE SHARE OF THE LGU WITH PHILIPPINE CHARITY SWEEPSTAKES OFFICE (PCSO) COVERING CY 2014 TO 2018 AMOUNTING TO PHP756,096.05 FOR THE PURCHASE OF MEDICINES, MEDICAL LABORATORY AND DENTAL SUPPLIES FOR RHU I AND RHU II"

WHEREAS, the Sangguniang Bayan of Umingan, Pangasinan submitted its Resolution No. 55, Series of 2019 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of Umingan, Pangasinan thru MDC Resolution No. 6, S-2019 dated October 16, 2019 has identified the programs/projects and activities to be funded by the unappropriated share of the LGU in the PCSO CY 2014-2018 in the amount of P756,096.05 and endorsed to the Sangguniang Bayan for approval;

WHEREAS, the Sangguniang Bayan approved the Supplemental Investment Plan of the municipality thru Resolution No. 55, S-2019 dated October 21, 2019;

WHEREAS, the Sangguniang Bayan enacted Supplemental Budget No. 2 thru Appropriation Ordinance No. 2, S-2019 dated October 21, 2019 to support the implementation of the programs/projects embodied in their Supplemental Investment Program No. 2;


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order;
