APPROVING RESOLUTION NO. 07, S-2022 OF THE SANGGUNIANG BAYAN OF VILLASIS, PANGASINAN, ENTITLED “APPROVING THE 2022 SUPPLEMENTAL ANNUAL INVESTMENT PLAN NO. 01 AND OTHER ACTIVITIES RELATED TO THE 2018 AND 2019 COLLECTION OF BURLEY AND NATIVE TOBACCO EXCISE TAX PURSUANT TO REPUBLIC ACT NO. 8240, AS AMENDED BY REPUBLIC ACT NO. 10351 IN THE TOTAL AMOUNT OF ONE HUNDRED SEVEN MILLION SIX HUNDRED SEVENTY THREE THOUSAND FIVE HUNDRED FIFTY NINE PESOS (P107,673,559.00)”

WHEREAS, the Sangguniang Bayan of Sta. Barbara, Pangasinan submitted its Resolution No. 07, S-2022 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

1. The Local Development Council of Villasis, Pangasinan has identified programs/projects to be funded from the municipality’s CYs 2018 and 2019 share from Tobacco Excise Tax. These are embodied in the municipality’s Supplemental Annual Investment Plan No.01 which was endorsed to the Sangguniang Bayan for approval through MDC Executive Committee Resolution No. 05-2021 on December 23, 2021;

2. The CY 2022 Supplemental Annual Investment Program No.01 which has a total investment requirement amounting to Php107,673,559.00 covers the implementation of development projects that are consistent with Local Budget Memorandum Nos. 83 & 84 both dated November 22, 2021; and
3. To support the implementation of the Supplemental Annual Investment Program No. 01, the Sangguniang Bayan enacted Supplemental Budget No. 01 on January 18, 2022 through Appropriation Ordinance No. 01 Calendar Year 2022.


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Villasis, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Rosary Gracia P. Perez-Tababa and Nicholi Jan Louie Q. Sison and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jeanne Jinky C. Zaplan, duly seconded, it was—


RESOLVED, by the Sangguniang Panlalawigan in session assembled, to approve Resolution No. 07, S-2022 of the Sangguniang Bayan of Villasis, Pangasinan, entitled “Approving the 2022 Supplemental Annual Investment Plan No. 01 and other activities related to the 2018 and 2019 collection of Burley and Native Tobacco Excise Tax pursuant to Republic Act No. 8240, as amended by Republic Act No. 10351 in the total amount of One Hundred Seven Million Six Hundred Seventy Three Thousand Five Hundred Fifty Nine Pesos (P107,673,559.00)”;
