PROVINCIAL RESOLUTION NO. 403-2022

REQUESTING THE PANGASINAN POLICE PROVINCIAL OFFICE TO ASSIST THE OFFICE OF THE PROVINCIAL VETERINARY TO MAN QUARANTINE CHECKPOINTS FOR THE FULL IMPLEMENTATION OF LAWS AND ORDINANCES PERTAINING TO AGRICULTURAL AND VETERINARY PRODUCTS

WHEREAS, the Sangguniang Panlalawigan has conducted a question hour to inquire on the prevailing situation of egg supply as well as its production and prices in the Province of Pangasinan;

WHEREAS, one of the concerns raised during the said question hour is the checking on the imposition of inspection or regulation fees on animal/poultry products;

WHEREAS, the Office of the Provincial Veterinary has manifested that they need the assistance of the Pangasinan Police Provincial Office to implement laws and ordinances pertaining to agricultural and veterinary products considering that they are undermanned;

WHEREAS, it is incumbent upon the Sangguniang Panlalawigan to request the Pangasinan Police Provincial Office to assist the Office of the Provincial Veterinary to man quarantine checkpoints to enable them regulate and inspect poultry and other products being shipped in and out of the Province;




