APPROVING RESOLUTION NO. 30-03222021 OF THE SANGGUNIANG BAYAN OF POZORRUBIO, PANGASINAN, ENTITLED "APPROVING THE FIRST (1ST) SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM FOR CY 2021 FUNDED BY REVERSION OF APPROPRIATION OF ABOLISHED POSITIONS AND REVERSION OF APPROPRIATION FOR PAYABLES OF POZORRUBIO, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Pozorrubio, Pangasinan submitted its Resolution No. 30-03222021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of Pozorrubio, Pangasinan has formulated and endorsed the municipality's First Supplemental Investment Program thru MDC Resolution No. 01, S-2021 dated February 15, 2021 to the Sangguniang Bayan for approval. This is in pursuance to Sections 106, 109 and 114 of RA 7160;

WHEREAS, the First Supplemental Investment Program with an investment requirement amounting to P8,881,690.02 covers the salaries and other personal benefits of the 27 newly-created plantilla item positions in some municipal offices and fund augmentation for the disaster risk reduction and management activities of the municipality;
