**APPROVING RESOLUTION NO. 2020-78 OF THE SANGGUNIANG BAYAN OF MANGALDAN, PANGASINAN, ENTITLED “APPROVING AND ADOPTING THE SUPPLEMENTAL ANNUAL INVESTMENT PLAN NO. 2 FOR CY 2020 OF THE MUNICIPALITY OF MANGALDAN, PANGASINAN”**

**WHEREAS**, the Sangguniang Bayan of Mangaldan, Pangasinan submitted its Resolution No. 2020-78 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Municipal Development Council – Executive Committee of Mangaldan, Pangasinan has prepared the municipality’s Supplemental Annual Investment Program No. 2 for CY 2020. This was endorsed by the Council, through MDC Resolution No. 2, Series of 2020 dated March 27, 2020 to the Sangguniang Bayan for approval;

**WHEREAS**, the Sangguniang Bayan approved said endorsement through Sangguniang Bayan Resolution No. 2020-78 dated March 27, 2020;

**WHEREAS**, said Supplemental AIP, which has a total investment requirement of P34,893,948.01, is intended to finance projects and activities such as the purchase of Medicines and Medical Supplies, Relief Goods, and Other Supplies and Materials and such other Related Services to address the COVID-19 crisis situation in the Municipality of Mangaldan;

**WHEREAS**, funding for this Supplemental AIP is embodied in the Supplemental Budget No. 2, CY 2020, and approved by their Sangguniang Bayan through Appropriation Ordinance No. 2020-02 dated March 27, 2020;


**WHEREAS**, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order;


