RESOLUTION NO. 408-2022

DECLARING MUNICIPAL ORDINANCE NO. 8-2021 OF THE SANGGUNIANG BAYAN OF ANDA, PANGASINAN, ENTITLED “AN ORDINANCE INSTITUTIONALIZING THE PRIVILEGES, BENEFITS, PROGRAMS AND SERVICES FOR SOLO PARENTS AND THEIR CHILDREN IN THE MUNICIPALITY OF ANDA, PANGASINAN AND APPROPRIATING FUNDS THEREFOR AND FOR OTHER PURPOSES” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Anda, Pangasinan submitted its Municipal Ordinance No. 8-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Sections 16, 17 (b) (2) (iv) of R. A. No. 7160, Republic Act No. 8972 otherwise known as “An Act Providing for Benefits and Privileges to Solo Parents and Their Children, Appropriating Funds Therefor and for Other Purposes and Memorandum Circular No. 08, S, 2004, issued by the Civil Service Commission, entitled: “Guidelines on the Grant of Parental Leave to Solo Parents”;

WHEREAS, however, the Sangguniang Bayan shall indicate the definite amount of funds sought to be allotted to finance the particular purpose of the subject ordinance, so as not to affect other funds already appropriated for specific purposes;
