APPROVING RESOLUTION NO. 94, S-2018 OF THE SANGGUNIANG BAYAN OF BASISTA, PANGASINAN, ENTITLED "APPROVING THE PROPOSED COMPREHENSIVE LAND USE PLAN FOR PLANNING PERIOD 2018-2027 OF THE MUNICIPALITY OF BASISTA, PANGASINAN, AS PRESENTED BY THE MUNICIPAL PLANNING TEAM"

WHEREAS, the Sangguniang Bayan of Basista, Pangasinan submitted its Resolution No. 94, Series of 2018 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, and Provincial Land Use Committee, have conducted initial review and study on said resolution and found out that the same was enacted pursuant to Section 447 (a) (2) (vii) of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Comprehensive Land Use Plan (CLUP) of Basista, Pangasinan had undergone the technical review by the Provincial Land Use Committee (PLUC) of the Province of Pangasinan pursuant to the guidelines of Memorandum Circular No. 2000-130 of the Department of the Interior and Local Government as embodied in Section 2 (b) of Executive Order No. 72, S-1993;

WHEREAS, the PLUC certified that the Municipality had incorporated in the final draft of the CLUP its recommendations and suggestions;
