RESOLUTION NO. 410-2019

APPROVING ORDINANCE NO. 94, S-2018 OF THE SANGGUNIANG BAYAN OF BASISTA, PANGASINAN, "AN **ENTITLED ORDINANCE AMENDING** INTEGRATED ZONING REGULATIONS OF THE MUNICIPALITY **OF** BASISTA, **PROVINCE** OF **PANGASINAN** AND **PROVIDING FOR** THE ADMINISTRATION, ENFORCEMENT AND AMENDMENT THEREOF AND FOR THE REPEAL OF ALL ORDINANCES IN CONFLICT THEREWITH"

WHEREAS, the Sangguniang Bayan of Basista, Pangasinan submitted its Ordinance No. 94, Series of 2019 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, and Provincial Land Use Committee (PLUC), have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Section 447 (a) (2) (ix) of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Zoning Ordinance of Basista, Pangasinan had undergone the technical review by the Provincial Land Use Committee (PLUC) of the Province of Pangasinan pursuant to the guidelines of Memorandum Circular No. 2000-130 of the Department of the Interior and Local Government as embodied in Section 2 (b) of Executive Order No. 72, S-1993;

WHEREAS, the Sangguniang Bayan of Basista, Pangasinan shall comply with the publication requirement per Section 59 of RA 7160 and per CLUP Guidebook (A Guide to Comprehensive Land Use Plan Preparation, Volume 1, 2013) before the subject Zoning Ordinance is effected;

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order;

WHEREFORE, in view of the foregoing, on motion of SP Members Nestor D. Reyes and Von Mark R. Mendoza and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jose G. Peralta, Jr., duly seconded, it was –

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to approve Ordinance No. 94, S-2018 of the Sangguniang Bayan of **Basista**, Pangasinan, entitled "An Ordinance amending the Integrated Zoning Regulations of the Municipality of Basista, Province of Pangasinan and providing for the administration, enforcement and amendment thereof and for the repeal of all ordinances in conflict therewith";
