RESOLUTION NO. 410-2022

DECLARING MUNICIPAL ORDINANCE NO. 02, S-2022 OF THE SANGGUNIANG BAYAN OF BANI, PANGASINAN, ENTITLED “AN ORDINANCE UPGRADING THE SALARY GRADE OF NURSE II POSITION FROM SALARY GRADE 15 (SG-15) TO SALARY GRADE 16 (SG-16) IN CONFORMITY WITH THE GUIDELINES ISSUED BY THE DEPARTMENT OF BUDGET AND MANAGEMENT PURSUANT TO DBM BUDGET CIRCULAR NO. 2021-2” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT


