**RESOLUTION NO. 411-2022**

**DECLARING MUNICIPAL ORDINANCE NO. 2020-05 OF THE SANGGUNIANG BAYAN OF BOLINAO, PANGASINAN, ENTITLED "AN ORDINANCE RECLASSIFYING PARCELS OF LAND OWNED BY PANGASINAN PROPERTY AND MINING CORPORATION (PPMC) COVERED BY TAX DECLARATION NOS. 12-0018-00137, 12-0018-00095, 12-0018-0063, 12-0018-00127, 12-0018-00027, 12-0018-00094 LOCATED AT BARANGAY LUCIENTE 2, BOLINAO, PANGASINAN FROM AGRICULTURAL TO RESIDENTIAL/COMMERCIAL/LIGHT INDUSTRIAL LAND" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT**

**WHEREAS**, the Sangguniang Bayan of Bolinao, Pangasinan submitted its Municipal Ordinance No. 2020-05 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer, Provincial Planning and Development Coordinator, Provincial Agrarian Reform Program Officer II, and Department of Human Settlements and Urban Development Regional Director have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Sections 20 and 447 (a) (2) (viii) of R.A. No. 7160 and Rule VII Article 38 of the Implementing Rules and Regulations of R.A. 7160;

**WHEREAS**, the Municipality of Bolinao has an existing Zoning Ordinance implementing its Comprehensive Land Use Plan CY 2017-2026;




