APPROVING RESOLUTION NO. 111, S-2019 OF THE SANGGUNIANG BAYAN OF BINMALEY, PANGASINAN, ENTITLED "ADOPTING THE COMPREHENSIVE LAND USE PLAN OF THE MUNICIPALITY OF BINMALEY FOR 2018-2027"

WHEREAS, the Sangguniang Bayan of Binmaley, Pangasinan submitted its Resolution No. 111, Series of 2019 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, and Provincial Land Use Committee, have conducted initial review and study on said resolution and found out that the same was enacted pursuant to Section 447 (a) (2) (vii) of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Comprehensive Land Use Plan (CLUP) of Binmaley, Pangasinan had undergone the technical review by the Provincial Land Use Committee (PLUC) of the Province of Pangasinan pursuant to the guidelines of Memorandum Circular No. 2000-130 of the Department of the Interior and Local Government as embodied in Section 2 (b) of Executive Order No. 72, S-1993;

WHEREAS, the PLUC certified that the Municipality had incorporated in the final draft of the CLUP its recommendations and suggestions;
