DECLARING ORDINANCE NO. 02-2020 OF THE SANGGUNIANG BAYAN OF SAN JACINTO, PANGASINAN, ENTITLED "AN ORDINANCE CREATING THE POSITION OF ONE (1) MEDICAL TECHNOLOGIST II WITH SALARY GRADE 15 AND APPROPRIATING FUNDS THEREOF UNDER THE MUNICIPAL HEALTH OFFICE OF THE MUNICIPALITY OF SAN JACINTO, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT
