**APPROVING SB RESOLUTION NO. 03-21-12 OF THE SANGGUNIANG BAYAN OF MABINI, PANGASINAN, ENTITLED "APPROVING/ADOPTING THE SUPPLEMENTAL INVESTMENT PROGRAM 1 (SIP) SERIES OF 2021 OF THE LGU OF MABINI, PANGASINAN"**

**WHEREAS**, the Sangguniang Bayan of Mabini, Pangasinan submitted its SB Resolution No. 03-21-12 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer and the Provincial Legal Officer, have conducted initial review and study on said SB Resolution and found out that the Supplemental Investment Program No. 1 of the municipality covers the implementation of the Construction/Concreting of Local Road proposed to be funded by the Department of Interior and Local Government/Department of Budget and Management through the Local Government Support Fund – Other Financial Assistance to LGUs in the amount of P14,6000,000.00. This was endorsed to the Sangguniang Bayan for approval on February 26, 2021 by the Municipal Development Council Executive Committee through MDC Executive Committee Resolution No. 01, Series of 2021;

**WHEREAS**, the project is in accordance with Local Budget Circular No. 131 of the Department of Budget and Management dated January 8, 2021 "Guidelines on the Release and Utilization of the Local Government Support Fund – Other Financial Assistance to Local Government Units in the FY 2021 General Appropriations Act 11518";


