RESOLUTION NO. 412-2022

DECLARING ORDINANCE NO. 166, S-2021 OF THE SANGGUNIANG BAYAN OF BASISTA, PANGASINAN, ENTITLED "AN ORDINANCE INSTITUTIONALIZING THE ALLOCATION OF SUPPORT FUNDS TO THE LOCAL COUNCIL OF WOMEN OF THE MUNICIPALITY OF BASISTA, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG TO ENACT

WHEREAS, the Sangguniang Bayan of Basista, Pangasinan submitted its Ordinance No. 166, S-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Sections 16, 17 (b) (2) (iv) and 447 (a) (2) (i) of R. A. No. 7160 and DILG Memorandum Circular No. 2006-125, entitled: Amendment of DILG MC No. 2002-167 dated 10 October 2002 (Guidelines on the Procedures and Structures for the Creation of Local Councils of Women)";

WHEREAS, subject ordinance shall take effect after compliance with the requirements of posting pursuant to Sections 59 (c) of R. A. No. 7160;




