**RESOLUTION NO. 413-2022**

**DECLARING ORDINANCE NO. 175, S-2022 OF THE SANGGUNIANG BAYAN OF BASISTA, PANGASINAN, ENTITLED “AN ORDINANCE INSTITUTIONALIZING THE ALLOCATION OF SUPPORT FUNDS TO THE OPERATION AND ADMINISTRATION OF PANTAWID PAMILYANG PILIPINO PROGRAM (4Ps) PARENT LEADERS ASSOCIATION OF THE MUNICIPALITY OF BASISTA, PANGASINAN AND FOR OTHER PURPOSES” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT**

**WHEREAS**, the Sangguniang Bayan of Basista, Pangasinan submitted its Ordinance No. 175, S-2022 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Sections 17 (b) (2) (iv) and 447 (a) of R. A. No. 7160 and Republic Act No. 11310, otherwise known as the “Pantawid Pamilyang Pilipino Program (4Ps) Act”;


