RESOLUTION NO. 415-2021

APPROVING RESOLUTION NO. 330, S-2019-22 OF THE SANGGUNIANG PANLUNGSOD OF URDANETA, PANGASINAN, ENTITLED "APPROVING THE ANNUAL INVESTMENT PROGRAM (AIP) CY 2021 OF THE CITY OF URDANETA IN THE AMOUNT OF ONE BILLION TWO HUNDRED EIGHTY-TWO MILLION THREE HUNDRED EIGHTY-THREE THOUSAND FOUR HUNDRED NINETY-NINE PESOS AND 6/100 CENTAVOS (P1,282,383,499.06)"

WHEREAS, the Sangguniang Panglungsod of Urdaneta, Pangasinan submitted its SP Resolution No. 330, Series of 2019-22 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said SP Resolution with the following findings:

1. The Local Development Council of Urdaneta City, Pangasinan has formulated the city's Annual Investment Program for Calendar Year 2021, which was endorsed to the Sangguniang Panlungsod for approval through CDC Resolution No. 330, Series of 2019-22. This is in pursuance to Sections 106, 109 and 114 of the Local Government Code of 1991;
2. The AIP of the city is in accordance with the Budget Operations Manual for LGUs, 2016 Edition and in pursuance to DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1, S-2007 dated March 8, 2007 and DBM-CCC-

DILG Joint Memorandum Circular No. 2014-01 dated August 7, 2014, as amended by DBM-CCC-DILG Joint Memorandum Circular No. 2015-01 dated July 23, 2015. The AIP was formulated following the prescribed AIP Summary Form categorized into general public, social, economic and other services. It likewise covers (a) all the regular budgetary items for the operations of the different city offices broken down into PS, MOOE and Capital Outlay; (b) the priority development programs/projects and those to be funded by the 20% development fund; and (c) disaster risk reduction management programs/projects/activities of the city. It further includes the following 1) Gender and Development Plan, Peace and Order Plan, Local Nutrition Plan, Tourism/Cultural Development Plan, Climate Change Action Plan, and 2) List of programs/projects/activities for the Local Council for the Protection of Children, Women, Senior Citizens and Persons with Disabilities, PPAs to combat Acquired Immune Deficiency Syndrome, and to address Problems on Illegal Drugs;

3. The AIP has a total investment requirement of 1,282,383,499.06 which will be funded from the city's proposed 2021 Annual Budget, enacted on November 24, 2020 through City Ordinance No. 32, Series of 2019-22;
4. The development fund amounting to P127,000,000.00 which is allocated for development projects is equivalent to the 20% of the city's IRA amounting to P634,793,660.00 for CY 2021. This is accordance with Section 287 of RA 7160;
5. The identified development programs/projects to be funded by the 20% of IRA are based on the DILG-DOF-DBM Joint Memorandum Circular No. 1 dated November 4, 2020 (Revised Guidelines on the Appropriation and Utilization of the 20% of the Annual Internal Revenue Allotment for Development Projects);
6. The identified programs/projects/activities to be funded by the 5% Local Disaster Risk Reduction and Management Fund of the city amounting to P64,208,584,08 conforms with Section 21 of RA 10121 and NDRRMC-DBM-DILG Joint Memo Circular No. 2013-1 dated March 25, 2013 (*Allocation and Utilization of Local Disaster Risk Reduction and Management Fund*). It is recommended that the LDRRM Plan be submitted to the Office of the Civil Defense for review as provided under item no. 2.2 of the Department of Budget and Management-Local Budget Memorandum Circular No. 77 dated May 15, 2018;
7. The LGU has also identified programs/projects/activities responsive to climate change and tagged its corresponding expenditures in their AIP. This is in pursuance to DBM-CCC-DILG Joint Memorandum Circular No. 2015-01 dated July 23, 2015;

9. The LGU has also included programs/projects to be funded by external Sources.


