**RESOLUTION NO. 415-2022**

**DECLARING ORDINANCE NO. 10, S-2021 OF THE SANGGUNIANG BAYAN OF CALASIAO, PANGASINAN, ENTITLED "AN ORDINANCE TRANSFERRING THE POSITION OF ADMINISTRATIVE AIDE I (UTILITY WORKER – I) WITH SALARY GRADE 1, FROM THE PUBLIC EMPLOYMENT AND SAFETY OFFICE (PESO) TO THE GENERAL SERVICES OFFICE (GSO)" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG TO ENACT**


