This is embodied in the municipality's First Supplemental Annual Investment Program which was endorsed thru MDC Resolution No. 01, Series of 2020 dated April 15, 2020 to the Sangguniang Bayan for approval;

**WHEREAS**, the Sangguniang Bayan thru Resolution No. 47-04222020 dated April 22, 2020 approved the First Supplemental Annual Investment Program of the municipality;
