**DECLARING MUNICIPAL ORDINANCE NO. 01-2022 OF THE** SANGGUNIANG BAYAN OF MANAOAG, PANGASINAN, **ENTITLED "AN ORDINANCE AMENDING ORDINANCE NO. 13-**2021 CAPTIONED "CREATING THE PLANTILLA POSITION OF MUNICIPAL RISK REDUCTION AND MANAGEMENT **OFFICER V (LDRRMO V) OF LGU MANAOAG, PANGASINAN"** TO **"CREATING** THE OF POSITION **MUNICIPAL** GOVERNMENT DEPARTMENT HEAD I (LOCAL RISK **REDUCTION AND MANAGEMENT OFFICER)" AS WITHIN** THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT
