RESOLUTION NO. 42-2021

DECLARING MUNICIPAL ORDINANCE NO. 2020-07 OF THE SANGGUNIANG BAYAN OF BUGALLON, PANGASINAN, ENTITLED “AN ORDINANCE CREATING TWELVE NEW POSITIONS AND ABOLISHING TWO VACANT POSITIONS IN THE MUNICIPALITY OF BUGALLON, PANGASINAN” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Bugallon, Pangasinan submitted its Municipal Ordinance No. 2020-07 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Local Finance Committee, have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Section 447 (a) (1) (viii) of RA 7160;

WHEREAS, however, the Sangguniang Bayan shall comply with the following observations of the Local Finance Committee, to wit:

1. The salary grade allocation of Accountant II should be adjusted from SG-15 to SG-16 as said position is included in Annex “B” of Budget Circular No. 2009-92 dated September 3, 2009 – List of Re-allocated Classes Positions;
2. The position of Engineering Aide A, Salary Grade 6 is allowed for Internal Utility Group (IUG) and what is allowed for local government units is Engineering Aide, Salary Grade 4; and

3. The positions of Internal Audit IV, Salary Grade 24 and Internal Auditing Assistant are created to man the Internal Audit Service/Unit, a new office as presented in the Calendar Year 2021 Annual Budget of the municipality. An ordinance creating said office enumerating the official functions should be enacted by the Sangguniang Bayan.

WHEREFORE, in view of the foregoing, on motion of SP Members Nestor D. Reyes and Von Mark R. Mendoza and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jeanne Jinky C. Zaplan, duly seconded, it was


