RESOLUTION NO. 42-2022

APPROVING RESOLUTION NO. 2021-242 OF THE SANGGUNIANG BAYAN OF MANGALDAN, PANGASINAN, ENTITLED "APPROVING AND ADOPTING THE ANNUAL INVESTMENT PROGRAM (AIP) CY 2022 OF THE MUNICIPALITY OF MANGALDAN, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Mangaldan, Pangasinan submitted its SB Resolution No. 2021-242 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution and found out that the same is in pursuant to Sections 106, 109 and 114 of R.A. 7160;

WHEREAS, the Municipal Development Council of Mangaldan, Pangasinan had identified and prioritized programs and projects in their Annual Investment Program for CY 2022. This was endorsed by the Council to the Sangguniang Bayan through MDC Resolution No. 4, S-2021 dated October 13, 2021;

WHEREAS, the Annual Investment Program of said LGU is in accordance with the Budget Operations Manual (BOM) for Local Government Units, 2016 Edition, and in pursuance to DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1, Series of 2007 dated March 8, 2007 and DBM-CCC-DILG JMC No. 2015-1 dated July 23, 2015 as to format and content. The AIP was prepared using the prescribed AIP Summary Form, and covers: (a) all the regular budgetary requirements for the operation of the different offices, broken down into Personal Services (PS), Maintenance and Other Operating Expenses (MOOE) and Capital Outlay, (b) priority

development programs/projects of the LGU, including those funded by the 20% Development Fund, (c) Local Disaster-Risk Reduction and Management (LDRRM) programs, projects, and activities, and (d) activities in pursuance of the objectives of Gender and Development (GAD) of the LGU;

WHEREAS, also attached to the AIP, among others, are the following: (a) Local Climate Change Adaption Plan, CY 2022, (b) Peace and Order and Public Safety Action Plan, CY 2022, (c) Municipal Nutrition Action Plan. CY 2022, (d) Municipal Tourism and Cultural Development Plan, CY 2022, (e) List of PPAs for the Local Council for the Protection of Children, CY 2022, (f) List of PPAs for Senior Citizens and Persons with Disabilities, CY 2022, (g) List of PPAs for the Prevention and Control of STI, HIV & AIDS, CY 2022, and (h) List of PPAs to Address the Problem on Illegal Drugs, or Municipal Anti-Drug Abuse Plan of the LGU, and Local Youth Development Plan (CY 2020-2022), and Devolution Transition Plan (CY 2022-2024);

WHEREAS, the AIP of Mangaldan for CY 2022 has a total investment requirement of P12,001,520,766.00. Of this, P455,461,766.00 will be financed by the LGU as embodied in their 2022 Annual Budget passed and approved by their Sangguniang Bayan through Appropriation Ordinance No. 2021-22 dated November 5, 2021. The remaining amount of P11,546,059,000.00 will be outsourced from various Government Agencies (local and national);

WHEREAS, said AIP is in accordance with Section 287 of LGC of 1991. More than 20% of the LGU's Internal Revenue Allotment/National Tax Allotment (P354,411,766.00), amounting to P71,000,000.00, is allocated for development projects;

WHEREAS, the development projects proposed to be funded by the 20% Development Fund were based on the Joint DBM-DILG Memorandum Circular No. 1 dated November 4, 2020 (Revised Guidelines on the Appropriation and Utilization of the 20% of the Annual Internal Revenue Allotment for Development Projects);

WHEREAS, the programs and projects included in the 5% Local Disaster Risk Reduction and Management Investment Plan/Program, amounting to **P21,420,000.00**, were already reviewed by Office of the Civil Defense - Regional Office I as part of the LGU's Six-Year LDRRM Plan (2019-2025) and the LGU was advised to consider and adopt the necessary amendments to the Plan and submit the revised Plan to the OCD-ROI;

WHEREAS, the Gender and Development Plan and Budget (2022) of the LGU was reviewed and approved by the DILG Provincial Office, and found to be compliant in form and content with the provisions of the PCW-DILG-DBM-NEDA Joint Memorandum Circular (JMC) Nos. 2013-01 and 2016-01 (Guidelines on the Localization of the Magna Carta of Women);

> WHEREAS, the LGU of Mangaldan had also identified programs, projects and activities which are responsive to Climate Change and tagged its corresponding expenditures in their AIP. This is in pursuance to DBM-CCC-DILG Joint Memorandum Circular No. 2015-01 dated July 23, 2015;

> WHEREAS, as to the implementation of the Devolution Transition Plan (CYs 2022-2024) of the LGU, it is respectfully recommended that the LGU should strictly observe provisions of Executive Order No. 138 dated June 1, 2021 and DILG-DBM Joint Memorandum Circular No. 2021-1 dated August 11, 2021.

> WHEREAS, however, the Municipality of Mangaldan shall comply with the opinion of the Local Finance Committee of the Province on the review of the LGU's Annual Budget for CY 2022;

> WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Mangaldan, Pangasinan;

> WHEREFORE, in view of the foregoing, on motion of SP Members Jeremy Agerico B. Rosario and Liberato Z. Villegas and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jeanne Jinky C. Zaplan, duly seconded, it was-

> RESOLVED, by the Sangguniang Panlalawigan in session assembled, to approve Resolution No. 2021-242 of the Sangguniang Bayan of Mangaldan, Pangasinan, entitled "Approving and adopting the Annual Investment Program (AIP) CY 2022 of the Municipality of Mangaldan, Pangasinan";
