#### APPROVING RESOLUTION NO. 2020-090 OF THE SANGGUNIANG BAYAN OF SISON, PANGASINAN, ENTITLED "APPROVING THE 3<sup>RD</sup> SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM CY 2020 OF THE MUNICIPALITY OF SISON, PANGASINAN"

**WHEREAS**, the Sangguniang Bayan of Sison, Pangasinan submitted its Resolution No. 2020-090 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that on March 27, 2020, the Local Disaster Risk Reduction Management Council has amended the municipality's DRRMF Plan for CY 2020 to address the disaster response requirements for the COVID-19 pandemic. This was recommended for approval by the Sangguniang Bayan through MDRRMC Resolution No. 02-2020;

**WHEREAS**, on March 23, 2020, the Sangguniang Bayan through Resolution No. 2020-088 approved the amended Municipal Disaster Risk Reduction and Management Fund (MDRRMF) Investment Plan of the municipality;

**WHEREAS**, the programs/projects to address COVID-19 is embodied in the 3<sup>rd</sup> Supplemental Annual Investment Program of the municipality which was endorsed by the Local Development Council through MDC Resolution No. 03-2020 dated March 27, 2020 to the Sangguniang Bayan for approval;
