APPROVING RESOLUTION NO. 2020-097 OF THE SANGGUNIANG BAYAN OF SISON, PANGASINAN, ENTITLED "APPROVING THE 4TH SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM CY 2020 OF THE MUNICIPALITY OF SISON, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Sison, Pangasinan submitted its Resolution No. 2020-097 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of Sison, Pangasinan has formulated, adopted and endorsed the municipality's 4th Supplemental Annual Investment Program through MDC Resolution No. 04-2020 dated April 9, 2020 to the Sangguniang Bayan for approval. This was approved by their Sangguniang Bayan on April 20, 2020 through Resolution No. 2020-097. This is in pursuance to Sections 106, 109, and 114 of RA 7160;

WHEREAS, the 4th Supplemental Annual Investment Program with an investment requirement amounting to P11,643,790.00 covers programs/projects/activities to address emergency response measures to COVID-19 pandemic. This will be funded from Bayanihan Grant to Cities and Municipalities (BGCM) under RA 11469 (The Bayanihan to Heal as One Act);

WHEREAS, on April 20, 2020, the Sangguniang Bayan enacted Supplemental Budget No. 01 through Appropriation Ordinance No. 01, Series of 2020 to support the implementation of the 4th Supplemental Investment Program of the municipality;

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order;
