PROVINCIAL RESOLUTION NO. 424-2022

AUTHORIZING THE PROVINCIAL GOVERNOR, AMADO I. ESPINO III, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT WITH THE NATIONAL COMMISSION FOR CULTURE AND THE ARTS (NCCA) FOR THE EFFECTIVE UTILIZATION OF THE NCCA GRANT IN THE PROVINCE OF PANGASINAN FOR THE IMPLEMENTATION OF THE PROJECT ENTITLED “MUSIC GEOGRAPHY OF PANGASINAN: FOLK AND TRADITIONAL SONGS”

WHEREAS, the National Commission for Culture and the Arts has approved a proposed project of the Province of Pangasinan entitled: *Music Geography of Pangasinan: Folk and Traditional Songs*” which could eventually contribute to the development of the Philippine culture and arts;

WHEREAS, the Project is supported by way of financial assistance in the amount of Five Hundred Thousand Pesos (P500,000.00) chargeable to the Program on Advancing the Value of Creative Excellence: Pagkamalikhain;

WHEREAS, a Memorandum of Agreement is necessary for the effective utilization of the fund to cover the expenses as stated in the Project Proposal and approved line item budget and schedule of activities chargeable under the said Program;

WHEREAS, it is to the best interest of the Provincial Government of Pangasinan to enter into and sign a Memorandum of Agreement with National Commission for Culture and the Arts for the implementation of the project;

WHEREAS, for the above purpose, a Memorandum of Agreement shall be entered into and signed between the Province of Pangasinan, represented by Governor Amado I. Espino III, and the National Commission for Culture and the Arts, represented by Honorable Marichu G. Tellano, Deputy Executive Director for Administration and Support Services;

WHEREFORE, in view of the foregoing, on motion of SP Member Margielou Orange D. Humilde-Verzosa, duly seconded, it was –


