#### PROVINCIAL RESOLUTION NO. 428-2020

AUTHORIZING THE PROVINCIAL GOVERNOR, AMADO I. ESPINO, III, TO NEGOTIATE AND ENTER INTO A LOAN AGREEMENT WITH THE LAND BANK OF THE PHILIPPINES IN THE AMOUNT OF EIGHT HUNDRED MILLION PESOS (P800 MILLION) UNDER THE TERMS AND CONDITIONS OF THE HEAL LENDING PROGRAM FOR COVID-19 PROGRAMS, PROJECTS AND ACTIVITIES

**WHEREAS**, it is the main objective of the Provincial Government of Pangasinan to generate and maximize the use of its resources and revenues for the development plans, program objectives and priority projects of the Province during this time of public health crisis brought about by COVID-19;

**WHEREAS**, the Land Bank of the Philippines has launched a program to help local government units supplement their initiatives in combating COVID-19 through the HEAL Lending Program;

**WHEREAS**, Provincial Government of Pangasinan would like to ensure the delivery of basic health and medical services not only to the people living in the urban areas but also to the countryside;

WHEREAS, due to budgetary constraints, the province cannot possibly prosecute all new programs, project and activities pertaining to COVID-19 expenses;

WHEREAS, the Provincial Government of Pangasinan will now avail of the emergency loan assistance offered by the Land Bank of the Philippines in the amount of Eight Hundred Million Pesos (P800 Million) to finance the strategic programs and projects of the Province;

WHEREAS, it is in the best interest of the Province to finance its various programs and projects to further strengthen its fight against COVID-19;
