DECLARING MUNICIPAL ORDINANCE NO. 5, S-2018 OF THE SANGGUNIANG BAYAN OF BAUTISTA, PANGASINAN, ENTITLED "AN ORDINANCE ENACTING THE REVENUE CODE OF THE MUNICIPALITY OF BAUTISTA, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Bautista, Pangasinan submitted its Ordinance No. 5, Series of 2018 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer and the Provincial Treasurer, have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Sections 129 and 132 of RA 7160;

WHEREAS, however, the Sangguniang Bayan shall consider the observations of the Provincial Legal Officer stated in their opinions dated May 23, 2019, which were not yet addressed by the Sanggunian, as attached in this Resolution;


