PROVINCIAL RESOLUTION NO. 429-2020

AUTHORIZING THE HONORABLE GOVERNOR, AMADO I. ESPINO III, TO PURCHASE ONE (1) UNIT OF MOTOR VEHICLE FOR USE BY THE PROVINCIAL GOVERNMENT OF PANGASINAN

WHEREAS, the Provincial Government of Pangasinan is in need of a motor vehicle which shall be used in the maintenance and operation of the executive management services and other related programs and projects particularly in the Provincial Records and Archives Center of the Province;

WHEREAS, the Provincial Government of Pangasinan intends to buy one (1) unit of motor vehicle with a total amount of P1,166,000.00 to be charged from the funds of the Office of the Governor, with the following specifications:

WHEREAS, it is to the best interest of the Provincial Government of Pangasinan to acquire said vehicle as a means to further enhance the services needed by the people;


