PROVINCIAL RESOLUTION NO. 429-2021

REQUESTING THE NATIONAL INTER-AGENCY TASK FORCE ON EMERGING INFECTIOUS DISEASES (IATF-EID) TO CONSIDER AN EARLY COVID-19 VACCINE ALLOCATION TO PROVINCIAL/MUNICIPAL/CITY LEGISLATORS OF THE PROVINCE OF PANGASINAN

WHEREAS, the national government has already started its vaccination roll out program for the past months and frontline health workers, senior citizens and persons with comorbidities who are listed on the top list have already received their shots;

WHEREAS, provincial/municipal/city legislators are included in the next category of the priority list of the Covid-19 vaccination program;

WHEREAS, provincial/municipal/city legislators are also at high risk of exposure especially in the performance of their legislative functions of regularly holding sessions, committee/public hearings and in the conduct of ocular inspections on matters that needed outright attention;

WHEREAS, early vaccination on their part would lessen the mortality and morbidity rate for legislators during this period of public health crisis;

WHEREAS, COVID-19 vaccination is a safer way to help build protection toward a severe infection for everybody especially the legislators who are mandated to perform their legislative duties;

WHEREAS, in Pangasinan alone, a number of legislators had been reportedly infected by COVID-19;


