RESOLUTION NO. 429-2022

DECLARING ORDINANCE NO. 170, S-2021 OF THE SANGGUNIANG BAYAN OF BASISTA, PANGASINAN. ENTITLED "AN ORDINANCE ESTABLISHING A GENDER-**VIOLENCE** BASED AND RAPE CASES RESPONSE MECHANISM AND PROTOCOL IN HANDLING GENDER-BASED VIOLENCE AND RAPE CASES IN THE MUNICIPALITY OF BASISTA, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Basista, Pangasinan submitted its Ordinance No. 170, S-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991:

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Sections 16, 17 (a) (iv) of R. A. No. 7160, and the following special penal laws or legislations, to wit: (a) Republic Act No. 9710 or "Magna Carta of Women", (b) Republic Act No. 11313 or "Safe Spaces Act, (c) Republic Act No. 10175 or "Cybercrime Prevention Act of 2012", (d) Republic Act No. 9208 or "Anti-Trafficking in Persons Act 2003", (e) Republic Act No. 9262 or "Anti-Violence Against Women and Their Children Act of 2004", (f) Republic Act No. 8505 or "Rape Victim Assistance and Protection Act of 1998", (g) Republic Act No. 7877 or "Anti-Sexual Harassment Act of 1995", and Joint Memorandum Circular No. 2010-2, dated December 9, 2010, entitled "Guidelines in the Establishment of a Violence Against Women (VAW) Desk in every Barangay";

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to declare Ordinance No. 170, S-2021 of the Sangguniang Bayan of Basista, Pangasinan, entitled "An Ordinance establishing a gender-based violence and rape cases response mechanism and protocol in handling gender-based violence and rape cases in the Municipality of Basista, Pangasinan" as within the conferred powers of the Sangguniang Bayan to enact;
