**WHEREAS**, the Provincial Government of Pangasinan is in need of motor vehicles which shall be used in the delivery of basic needs and for COVID-19 related programs, projects and activities;

**WHEREAS**, the Provincial Government of Pangasinan intends to purchase two (2) units of motor vehicle with a total amount of P5,930,076.00 with the following specifications:


**WHEREAS**, it is to the best interest of the Provincial Government of Pangasinan to acquire said vehicle as a means to further enhance the services needed by the people;

**NOW THEREFORE**, on motion of SP Member Angel M. Baniqued, Jr., duly seconded, it was -


