**RESOLUTION NO. 430-2022**

**DECLARING MUNICIPAL ORDINANCE NO. 1, S-2022 OF THE SANGGUNIANG BAYAN OF UMINGAN, PANGASINAN, ENTITLED “AN ORDINANCE CREATING ONE (1) POSITION WITH THE TITLE OF ADMINISTRATIVE ASSISTANT 1 (BOOKBINDER III-SG-7/1) AND ADMINISTRATIVE OFFICER V (BUDGET OFFICER III-SG-18/1), IN THE MUNICIPAL BUDGET OFFICE, TWO (2) POSITIONS WITH THE TITLE OF NURSE I (SG-11/1), IN THE RURAL HEALTH UNIT II, ONE (1) POSITION WITH THE TITLE OF SOCIAL WELFARE OFFICER III (SG-18/1) IN THE OFFICE OF THE MUNICIPAL SOCIAL WELFARE & DEVELOPMENT (MSWD), ONE POSITION WITH THE TITLE OF ADMINISTRATIVE AIDE IV (SG-4/1) IN THE MUNICIPAL ENVIRONMENT & NATURAL RESOURCES OFFICE AND ONE (1) POSITION WITH THE TITLE HEAVY EQUIPMENT OPERATOR III (SG-9/1) IN THE GENERAL SERVICES OFFICE (MOTOR POOL), AND LIKEWISE ABOLISHING ONE (1) POSITION WITH THE TITLE ADMINISTRATIVE OFFICER III (RECORDS OFFICER II SG-14/1) IN THE OFFICE OF THE SANGGUNIANG BAYAN SECRETARY AND ONE POSITION WITH THE TITLE OF NURSE V (SG-22) IN THE RURAL HEALTH UNIT OF UMINGAN, PANGASINAN” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG TO ENACT**

**WHEREAS**, the Sangguniang Bayan of Umingan, Pangasinan submitted its Municipal Ordinance No. 1, S-2022 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Sections 76 and 447 (a) (1) (viii) of R.A. No. 7160;

**WHEREAS**, however, the Salary Grade of Nurse I should be adjusted from Salary Grade 11 to Salary Grade 15 to conform with the provision of Budget Circular No. 2021-2 dated August 25, 2021 (Modification of Nurse Positions); and the position of one (1) Administrative Assistant V (Budget Officer III-SG 18/1) and one (1) Automotive/Heavy Equipment Operator III (SG-9/1) should be changed to Administrative Officer V and Heavy Equipment Operator III, respectively;

**WHEREFORE**, in view of the foregoing, on motion of SP Members Salvador S. Perez, Jr. and Noel C. Bince and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jeanne Jinky C. Zaplan, duly seconded, it was –

**RESOLVED**, by the Sangguniang Panlalawigan in session assembled, to declare Municipal Ordinance No. 1, S-2022 of the Sangguniang Bayan of Umingan, Pangasinan, entitled “An Ordinance creating one (1) position with the title of Administrative Assistant 1 (Bookbinder III-SG-7/1) and Administrative Officer V (Budget Officer III-SG-18/1), in the Municipal Budget Office, two (2) positions with the title of Nurse I (Sg-11/1), in the Rural Health Unit II, one (1) position with the title of Social Welfare Officer III (SG-18/1) in the Office of the Municipal Social Welfare & Development (MSWD), one position with the title of Administrative Aide IV (SG-4/1) in the Municipal Environment & Natural Resources Office and one (1) position with the title Heavy Equipment Operator III (SG-9/1) in the General Services Office (Motor Pool), and likewise abolishing one (1) position with the title Administrative Officer III (Records Officer II SG-14/1) in the Office of the Sangguniang Bayan Secretary and one position with the title of Nurse V (Sg-22) in the Rural Health Unit Of Umingan, Pangasinan” as within the conferred powers of the Sangguniang Bayan to enact;

**RESOLVED FURTHER**, that a copy of this resolution be furnished the Office of the Sangguniang Bayan of Umingan, Pangasinan, for its information and guidance.
