PROVINCIAL RESOLUTION NO. 434-2021

AUTHORIZING THE PROVINCIAL GOVERNOR AND THE PROVINCIAL TREASURER TO OPEN SEPARATE DEPOSIT BANK ACCOUNTS WITH THE LAND BANK OF THE PHILIPPINES-LINGAYEN BRANCH FOR PROFESSIONAL FEES AND DRUGS AND MEDICINES OF THE MANAOAG COMMUNITY HOSPITAL

WHEREAS, the Provincial Health Office Audit Team has conducted a special audit on financial management system of the Manaoag Community Hospital last November 17 and 24, 2020 and it recommended that the said community hospital opens a separate account for the Professional Fees being paid by PhilHealth and Drugs and Medicines to promote ease of monitoring and accounting of reimbursements coming from PhilHealth;

WHEREAS, pursuant to said recommendation, a separate bank account for the Professional Fees and Drugs and Medicines of Manaoag Community Hospital shall be opened with the Land Bank of the Philippines-Lingayen Branch;

WHEREAS, in view of the above premises, it is therefore necessary that the Provincial Governor and the Provincial Treasurer be authorized by the Sangguniang Panlalawigan to open separate deposit bank accounts with the Land Bank of the Philippines-Lingayen Branch for Professional Fees and Drugs and Medicines of the Manaoag Community Hospital;

NOW THEREFORE, on motion of SP Members Angel M. Baniqued, Jr. and Jeremy Agerico B. Rosario, duly seconded, it was -

RESOLVED, by the Sangguniang Panlalawigan in session assembled to authorize, as they are hereby authorized, the Provincial Governor and the Provincial Treasurer to open separate deposit bank accounts with the Land Bank of the Philippines-Lingayen Branch for Professional Fees and Drugs and Medicines of the Manaoag Community Hospital;




