WHEREAS, the Sangguniang Bayan of Sto. Tomas, Pangasinan submitted its Resolution No. 44, Series of 2019 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of Sto. Tomas, Pangasinan has formulated the municipality's Supplemental Investment Program No. 1, S-2019. The Sangguniang Bayan approved the Supplemental Investment Program No. 1, S-2019 on May 30, 2019 thru MDC Resolution No. 44, S-2019. This is in consonance to Sections 106, 109 and 114 of RA 7160;

WHEREAS, the Supplemental Investment Program of the municipality with an investment requirement of P343,538.00 covers the provision of salaries and other benefits of the newly created positions of Local Disaster Risk Reduction Management Officer II under the Office of the Mayor;
