**RESOLUTION NO. 435-2020**

**DECLARING THE SUPPLEMENTAL BUDGET NO. 1 FOR CALENDAR YEAR 2020 OF AGNO, PANGASINAN INVOLVING A TOTAL APPROPRIATION OF P18,720,669.00 OPERATIVE IN ITS ENTIRETY**

**WHEREAS**, pursuant to R.A. No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

**WHEREAS**, the Sangguniang Bayan of Agno, Pangasinan submitted its Supplemental Budget No. 1 for Calendar Year 2020 involving total appropriations of **P18,720,669.00** which was approved on April 6, 2020 through Appropriation Ordinance No. 2020-01 and approved by the Municipal Mayor on the same date;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee pursuant to Section 316 of the Local Government Code of 1991, have conducted preliminary review and study on said budget with the following findings:

1. All programs, projects and activities shall be in accordance with the approved Local Development Plan and FY 2020 Supplemental Investment Program of the municipality formulated pursuant to DILG-NEDA-DBM Joint Memorandum Circular No. 1, S-2007 dated 08 March 2007;

2. All procurements to be undertaken shall be subject to the pertinent provisions of RA No. 9184 (The Government Procurement Reform Act) and its revised Implementing Rules and Regulations; *and*
3. The full implementation of the First Tranche Salary Adjustment to all municipal officials and employees shall be in accordance with the provisions of Local Budget Circular No. 121 dated January 24, 2020 Re: Implementation of the First Tranche of the Modified Salary Schedule for Local Government Personnel pursuant to RA 11466.


**WHEREAS**, the Sangguniang Panlalawigan, after final evaluation, finds the same in order provided that the above-findings shall be complied with by the municipality;

**RESOLVED**, as it is hereby resolved, by the Sangguniang Panlalawigan in session assembled, to declare **OPERATIVE IN ITS ENTIRETY the Supplemental Budget No. 1 for Calendar Year 2020 of Agno, Pangasinan** as of the date fixed therein for its effectivity; subject to the posting requirements under Section 59 of RA 7160; and provided, that the disbursement of appropriations as approved shall be subject to the existing accounting and auditing rules and regulations, and compliance with other pertinent laws, rules and regulations shall be the responsibility of the Municipal Government of Agno;
