DECLARING MUNICIPAL ORDINANCE NO. 9-2020 OF THE SANGGUNIANG BAYAN OF ANDA, PANGASINAN, ENTITLED "AN ORDINANCE ESTABLISHING A SCHOLARSHIP PROGRAM THROUGH FINANCIAL ASSISTANCE IN THE MUNICIPALITY OF ANDA, PANGASINAN AND APPROPRIATING FUNDS RELATIVE THERETO" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Anda, Pangasinan submitted its Municipal Ordinance No. 9-2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer and the Local Finance Committee of the Province, have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Sections 447 (a) (5) (xi) of RA 7160; Republic Act No. 109311 otherwise known as "Universal Access to Quality Tertiary Education Act" and Republic Act No.10648 entitled, "An Act Providing Scholarship Grants to Top Graduates of all Public High Schools in State Universities and Colleges and Appropriating Funds Therefor";

WHEREAS, subject ordinance shall take effect after the requirement of posting pursuant to Section 59 of RA 7160 is complied with;
