**WHEREAS**, the Sangguniang Bayan of Dasol, Pangasinan submitted its SB Resolution No. 26, S-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution and found out that the subject resolution is in consonance to Sections 106, 109 and 114 of Republic Act No. 7160 otherwise known as the Local Government Code of 1991;
