INTERPOSING NO OBJECTION TO AND ENDORSING THE APPLICATION OF MS. KRystal GRACE L. NATIVIDAD FOR INDUSTRIAL SAND AND GRAVEL OPERATION TO BE SITUATED ALONG THE AGNO RIVER AT BARANGAY AMISTAD, TAYUG, PANGASINAN

WHEREAS, Ms. Krystal Grace L. Natividad, represented by his Attorney-in-Fact, Benson Dy Sua, in his letter dated April 4, 2022, requested the Sangguniang Panlalawigan for an indorsement of her application for Industrial Sand and Gravel Operation in Barangay Amistad, Tayug, Pangasinan to the DENR, Region I, San Fernando City, La Union;


