APPROVING RESOLUTION NO. 2019-438-056 OF THE SANGGUNIANG BAYAN OF BALUNGAO, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (SAIP) NO. 1, FOR THE CALENDAR YEAR 2019 OF THE MUNICIPALITY OF BALUNGAO, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Balungao, Pangasinan submitted its Resolution No. 2019-438-056 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of Balungao, Pangasinan has formulated the municipality's Supplemental Annual Investment Program No. 1, S-2019 and endorsed to the Sangguniang Bayan for approval thru MDC Resolution No. 2019-01 dated March 18, 2019. The Sangguniang Bayan approved the Supplemental Annual Investment Program No. 1, S-2019 on June 7, 2019 thru Resolution No. 2019-438-056. This is in consonance to Sections 106, 109 and 114 of RA 7160;

WHEREAS, the Supplemental Annual Investment Program No. 1 of the municipality with an investment requirement of P5,000,000.00 covers the implementation of development projects, and fund augmentation for the retirement and leave benefits and disaster risk reduction and management program of the municipality;
