PROVINCIAL RESOLUTION NO. 437-2022

AUTHORIZING THE PROVINCIAL GOVERNOR, AMADO I. ESPINO III, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF SCIENCE AND TECHNOLOGY- PHILIPPINE INSTITUTE OF VOLCANOLOGY AND SEISMOLOGY (DOST-PHIVOLCS) FOR THE INSTALLATION OF AN EARTHQUAKE INTENSITY METER INSIDE THE PREMISES OF THE PDRRMO BUILDING

WHEREAS, the Department of Science and Technology-Philippine Institute of Volcanology and Seismology (DOST-PHIVOLCS) intends to place earthquake intensity meters to be strategically located in key areas of the Province to enable it monitor and take more precise and faster readings of earthquakes;

WHEREAS, nine (9) units of earthquake intensity meter will be located in pre-selected areas of the province to include one in Lingayen, Pangasinan which is to be installed inside the premises of the PDRRMO Building;

WHEREAS, the earthquake intensity meter is composed of an accelerometer, an internet-based data transmission system and an uninterruptible power supply which can numerically evaluate the severity of earthquake-related ground shaking in the area of around the seismic sensor on near real-time basis;

WHEREAS, the installation of earthquake intensity meters in the Province will greatly contribute to the advancement of DOST-PHIVOLCS earthquake monitoring capability;

WHEREAS, the Sangguniang Panlalawigan fully supports the project of DOST-PHIVOLCS as a tool for seismologists to issue faster landslide and tsunami alerts, and save lives and property in the event of a strong earthquake;



NOW THEREFORE, on motion of SP Member Jerome Vic O. Espino, duly seconded, it was -


