APPROVING RESOLUTION NO. 2019-060 OF THE SANGGUNIANG BAYAN OF TAYUG, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL AIP PURSUANT TO APPROPRIATIONS ORDINANCE NO. 2019-001 OF THE MUNICIPALITY OF TAYUG, PANGASINAN INVOLVING AN AMOUNT OF FOUR MILLION FOUR HUNDRED THIRTY FOUR THOUSAND FORTY SEVEN PESOS AND 23/100 (P4,434,047.23)"

WHEREAS, the Sangguniang Bayan of Tayug, Pangasinan submitted its Resolution No. 2019-060 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of Tayug, Pangasinan has formulated the municipality's Supplemental Investment Program No. 1 for CY 2019 and endorsed to the Sangguniang Bayan for approval thru MDC Resolution No. 2019-04 dated May 23, 2019. The Sangguniang Bayan approved the Supplemental Investment Program No. 1 on June 6, 2019 thru Resolution No. 2019-060. This is in consonance to Sections 106, 109 and 114 of RA 7160;

WHEREAS, the Supplemental Investment Program No. 1 of the municipality with an investment requirement of P4,434,047.23 covers fund augmentation for the Maintenance and Other Operating Expenses of the Executive and Legislative Department and disaster risk reduction and management program of the municipality;


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order;
