RESOLUTION NO. 439-2020

DECLARING MUNICIPAL ORDINANCE NO. 2020-02 OF THE SANGGUNINAG BAYAN OF BOLINAO, PANGASINAN, ENTITLED "AN ORDINANCE REQUIRING MANDATORY USE OF FACE MASKS, STRINGENT PRACTICE OF SAFE PHYSICAL DISTANCING AND PRACTICING GOOD HYGIENE THROUGH FREQUENT HANDWASHING BY ALL PERSONS WHO ARE FOUND IN THE MUNICIPALITY OF BOLINAO DURING STATE OF PUBLIC HEALTH EMERGENCY OR ANY EXTENSION THEREOF" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Bolinao, Pangasinan submitted its Municipal Ordinance No. 2020-02 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Sections 16 and 447 (a) (1) (iii) of RA7160; DILG Memorandum Circular No. 2020-071 (Mandatory Wearing of Face Masks and other Protective Equipment in Public); and Provincial Ordinance No. 235-2020 (An Ordinance Requiring the Mandatory Wearing of Face Masks by all Persons in Public Places within the Territorial Jurisdiction of the Province of Pangasinan during the Period of Enhanced Community Quarantine and for any Extension thereof);

WHEREAS, subject ordinance shall take effect after the Sanggunian has complied with the requirements of posting and publication pursuant to Sections 59 (c) and 511 (a) of RA 7160;
