THIS IS TO CERTIFY that at the regular session duly constituted of the Sangguniang Panlalawigan, Province of Pangasinan, held on December 9, 1994 at Lingayen, Pangasinan, the following Provincial Ordinance was approved:

PROVINCIAL ORDINANCE NO. 44

AN ORDINANCE AMENDING PROVINCIAL ORDINANCE NO. 28, SERIES OF 1993, ENTITLED "GRANTING AN EXCLUSIVE FRANCHISE TO COLOR CABLE TO INSTALL, OPERATE AND MAINTAIN A CABLE TELEVISION SYSTEM (CATV) IN THE MUNICIPALITY OF CALASIAO, PANGASINAN AND OTHER PURPOSES"

WHEREAS, the Sangguniang Panlalawigan has approved Provincial Ordinance No. 28, granting an exclusive franchise to Color Cable to install, operate and maintain a cable television system (CATV) in Calasiao, Pangasinan on September 24, 1993;

WHEREAS, on October 6, 1993, Metro Dagupan CATV, Inc. - First Ilocandia Cable TV, Inc., has applied to operate, establish and maintain a CATV, also, in Calasiao, Pangasinan;

WHEREAS, after a series of study and evaluation of the Committee on Rules, Law and Justice on the matter of application of Metro Dagupan CATV, Inc.-First Ilocandia Cable TV, Inc., the said Committee under Committee Report No. 30 recommends that Provincial Ordinance No. 28 be amended so that the word "EXCLUSIVE" be changed to "NON-EXCLUSIVE" in the title and Section 2 thereof;

NOW, THEREFORE, in view of the foregoing, on motion of SP Member Dionisio C. Antiniw, duly seconded, be it enacted by the Sangguniang Panlalawigan in session assembled that:

SECTION 1. The title of Provincial Ordinance No. 28 shall be read as follows:

"AN ORDINANCE GRANTING A NON-EXCLUSIVE FRANCHISE TO COLOR CABLE TO INSTALL, OPERATE AND MAINTAIN A CABLE TELEVISION SYSTEM (CATV) IN THE MUNICIPALITY OF CALASIAO, PROVINCE OF PANGASINAN AND FOR OTHER PURPOSES"

SECTION 2. Section 1 of Provincial Ordinance No. 28 shall be read as follows:

"For a period of fifteen (15) years from the approval of this Ordinance, COLOR CABLE/SATELLITE CABLE TV, Inc., with corporate address at G/F Filco Showroom Complex, Rizal Street, Dagupan City, is hereby granted the non-exclusive right, privilege and authority to install, operate and maintain a cable television system (CATV) in the Municipality of Calasiao, Province of Pangasinan subject to the following terms and conditions" xxx.
