**APPROVING RESOLUTION NO. 159, S-2018 OF THE SANGGUNIANG BAYAN OF MAPANDAN, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NO. 2 CY-2018 OF THE MUNICIPALITY OF MAPANDAN, PROVINCE OF PANGASINAN"**

**WHEREAS**, the Sangguniang Bayan of Mapandan, Pangasinan submitted its Resolution No. 159, Series of 2018 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Municipal Development Council of Mapandan, Pangasinan has prepared the municipality's Supplemental Annual Investment Program No. 2 for CY 2018. This was endorsed by the Council, through MDC Resolution No. 03, S-2018 dated October 9, 2018, to the Sangguniang Bayan for approval;

**WHEREAS**, the Sangguniang Bayan approved said endorsement through Sangguniang Bayan Resolution No. 159, S-2018 dated October 15, 2018. This is in accordance to Sections 106, 109 and 114 of RA 7160;

**WHEREAS**, said Supplemental Investment Program, which has a total investment requirement of P42,000,000.00, covers the purchase of lot for rehabilitation/improvement/construction of, and acquisition of heavy equipment for the Material Recovery Facility;
