DECLARING MUNICIPAL ORDINANCE NO. 28, S-2021 OF THE SANGGUNIANG BAYAN OF AGUILAR, PANGASINAN, ENTITLED "AN ORDINANCE PROHIBITING ALL FORMS OF ILLEGAL GAMBLING IN THE MUNICIPALITY OF AGUILAR, PANGASINAN AND IMPOSING CHARGES ON VIOLATORS THEREOF" AS WITHIN THJE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Aguilar, Pangasinan submitted its Municipal Ordinance No. 28, S-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Sections 447 (a) (1) (v), (4) (vii) of RA 7160 otherwise known as the Local Government Code of 1991;

WHEREAS, subject ordinance shall take effect after compliance with the requirement of publication pursuant to Section 511 (a) of RA 7160;

WHEREFORE, in view of the foregoing, on motion of SP Members Nestor D. Reyes and Von Mark R. Mendoza and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jeanne Jinky C. Zaplan, duly seconded, it was
