PROVINCIAL RESOLUTION NO. 442-2019

RATIFYING THE DEED OF USUFRUCT ENTERED INTO AND SIGNED BETWEEN THE PROVINCE OF PANGASINAN AND THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES GRANTING THE LATTER THE RIGHT TO USE A PARCEL OF LAND CONTAINING AN AREA OF APPROXIMATELY 800 SQUARE METERS WITHIN THE CAPITOL COMPOUND

WHEREAS, Provincial Resolution No. 397-2019 of the Sangguniang Panlalawigan, dated July 29, 2019, authorized the Honorable Governor, Amado I. Espino, III, to enter into a Deed of Usufruct with the Department of Environment and Natural Resources for the use of a parcel of land containing an area of approximately 800 square meters within the Capitol Compound for the establishment of its provincial office and/or construction of its provincial building;

WHEREAS, the Sangguniang Panlalawigan introduced an amendment in the subject Deed of Usufruct during the discussion of the above-mentioned measure;

WHEREAS, the Provincial Governor, Amado I. Espino III, in representation of the Province, has signed the Deed of Usufruct with the Department of Environment and Natural Resources, represented by Regional Executive Director Carlito M. Tuballa, dated August 7, 2019;

WHEREAS, the Sangguniang Panlalawigan is already in receipt of the Deed of Usufruct and considering the importance of the subject property, it is imperative to ratify the same subject to certain conditions as stipulated thereat;
